- Develop and implement a fundraising strategy utilizing current and new tactics to grow every level of revenue generation.
- Oversee corporate sponsorship strategy, managing outsourced foundation grant work and secure government funding
- Drive the retention of current donors and the identification and cultivation of all financial supporters through extensive portfolio management across all levels of the organization
- Execute a Major Donor prospect strategy with a plan for every prospect.

The CAO is responsible for raising funds to support the Diocesan Council of Dallas initiatives and working with member Conferences across the Diocese to develop strategies and programs that leverage the national footprint of the Society, its many existing programs, and the 800+ Vincentian volunteers working across the Diocese.

#### **Development and Revenue Generation**

- Lead the efforts to increase revenues through corporate, individual, foundation and government funding and affiliate partnerships.
- Identify and implement new revenue streams and fundraising methods, with focus on increasing sustainable unrestricted, private revenue.
- Identify, assess, and promote grant opportunities and share with CEO, leadership volunteers, and staff while overseeing our grant partnership.
- Personally maintain a major gifts portfolio of qualified donors and prospects and oversee the portfolio management process for all team and Board members.
- Partner with CEO, Board of Directors, Leadership Team, and Board Advancement Committee to deepen existing funder relationships and cultivate new supporters.
- Evaluate and drive the use of new technology communications, marketing and funding vehicles including social media and online giving, leveraging the organization's website and online tools.
- Plan and evaluate financial needs and fundraising plans and budgets for the Diocesan Council's future.

#### **Communications and Marketing**

- Work with CEO and Board of Directors on public relations and marketing to increase knowledge and awareness of SVDP, its mission, activities, and the value of its work.
- Implement multifaceted communications strategy, including use of electronic mail, SVDP websites, social media platforms, print and broadcast media to disseminate SVDP policy, programs and activities, advocacy and related messaging to advance the SVDP mission.
- Focus on external communications to ensure consistent messaging and branding in all print and online donor, partner, and stakeholders' materials.
- With the finance staff, sustain efficient, effective, and transparent financial tracking and reporting processes.
- Coordinate media pitches and communication planning with public relations partner.

## **Board and Senior Staff Leadership**

- Work closely with CEO, Board Advancement Committee, and Advancement Team to lead the creation and implementation of a development strategy.
- Attend Diocesan Council board meetings and Advancement Committee meetings and report on development activities as needed, in coordination with the CEO.
- Serve as an ambassador and spokesperson for the organization as needed, and articulate our mission to external constituents, partner organizations, and current and potential funders.
- Work with the CEO and Council President (leadership volunteer and Board Chair) to ensure board members are engaged and energized by their association with our organization and mission and provide information as needed to board members on donor cultivation and fundraising techniques.
